1. Participant has elected to participate in horseback riding activity (“Riding Activity”) at the Black Horse Stables LLC horse facility (the “Premises”), managed by Black Horse Stables LLC (“Black Horse Stables”).
2. Participant acknowledges, agrees and understands that when in the presence of horses, there is always a risk of serious personal injury, death, and damage to property. The reasons for these risks include but are not limited to: the unpredictability of a horse's reaction to sounds, movement and unfamiliar objects, persons or other animals; natural and manmade hazards; weather; and, the riding or handling of a horse. Participant acknowledges that a horse, irrespective of its training and usual past behavior and characteristics, may act or react unpredictably at times which are an inherent risk to be assumed by Participant in connection with and during the Riding Activity or any other horse related activity therewith. Participant understands that participating in a Riding Activity and/or horse-related activity involves numerous risks of injury or death that is Participant’s own responsibility and Participant assumes these risks, regardless of Participant’s level of riding skills. Participant agrees to use all reasonable care to avoid these risks.
3. Participant, for him/herself, or by his/her legal guardian, and by and on behalf of his/her heirs, executors, successors, assigns, agents, estate, and personal representatives does hereby release, remise, forever discharge Black Horse Stables LLC, Worcester Stables Inc. and Crossroads Realty Company (the owners of the facility and Premises) and all of their respective affiliates, parent and subsidiary corporations, employees, officers, directors, agents, contractors, volunteers, assistants, insurers, attorneys, heirs, successors, assigns and any others acting on its behalf, as applicable (collectively, the “Indemnified Parties”) and indemnify and hold harmless each and every of the Indemnified Parties from and against any and all claims or liability that arise from: (1) any personal injury or death to Participant, Parent, Black Horse Stables, or their respective guests and invitees; or (2) any damage to property, or injury to or destruction of a horse that occurs in connection with or during the Riding Activity, or while Participant is performing any other horse-related activity at the Premises. The above referenced claims and liabilities, economic and/or non-economic losses due to bodily injury, death, or property damage shall include without limitation any and all to Participant, Black Horse Stables and their guests and invitees, sustained to or resulting from horses, whether on or off the Premises, and any and all demands, liabilities, causes of action, damages, costs, or claims for relief of whatever kind or nature, whether known or unknown, whether suspected or unsuspected, whether or not well-founded in fact or law, or, at law or in equity that result from Participant’s actions that are in any way connected with: (1) the representations and obligations set forth in this Release; and/or (2) Participant’s preparation for or participation in the Show or use of any horse stabled at the Premises.
4. Participant agrees to abide by all safety policies, warning signs, policies, procedures and rules of Black Horse Stables LLC that he/she is advised of, either verbally, or in writing.
5. Participant acknowledges that he/she has carefully read this Release and fully understands its contents. Participant acknowledges that he/she is aware that he/she is releasing certain legal rights that Participant otherwise may have, and has signed this Release of his/her own free will and not under duress. This Release shall be legally binding upon me, my heirs, my estate, assigns, legal guardians, and my personal representatives.
6. Payment in full must be sent in or delivered to the barn at least 1 week prior to the camp start date. Payment can be sent to Black Horse Stables, 1600 Potshop Rd., Norristown, Pa 19403
